1. The competition will be conducted following RSOBHD rules. The judge's decision is final. Only the competition organizer is authorized to communicate with the judge.
2. Age groups will be determined according to the number of entries. All competitors' ages determined as of the day of the competition May 13, 2023.
3. Your 2023 ScotDance card must be presented at time of registration.
4. We reserve the right to combine or cancel any event due to lack of participants, or to modify the schedule. If an event is canceled, competitors will be notified prior to the day of the event.
5. Dancers must be ready and appear to the Marshalling area when called or will forfeit the chance to dance in that event. The event will be run according to the "First to enter, last to dance" practice.
6. SDUSA registration cards will remain with the competition organizer throughout the competition and will be available at time of awards.
7. Medals will be awarded to 3 places or as determined by the judge & a class (aggregate) trophy will be awarded for all the dances in that class/age group. No class (aggregate) trophy will be awarded to the Primary class.
8. Highland & National dress to be worn in accordance with RSOBHD rules. **DANCERS MUST BE IN FULL COSTUME TO RECEIVE AWARDS.**
9. Protests must be made in writing and submitted to the Competition Organizer within 7 days of the event accompanied by a \$25 fee that will be refunded if the petition is warranted.
10. **Entries close May 3, 2023 & must be received by that date.**
